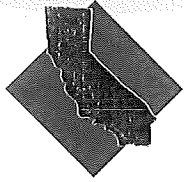

The California Association of Health Underwriters (CAHU) is pleased to **SUPPORT** your **AB 2576**, as introduced, which would change state tax laws pertaining to health savings accounts (HSAs) in order to provide savings to public and private sector employees and employers.

As introduced, **AB 2576** entitles individuals to a state tax deduction for contributions to a Health Savings Account (HSA) in conformity with recent changes to federal tax law. Health Savings Accounts allow individuals to save tax-free dollars to pay for near-term medical expenses and save for future longer-term costs. **AB 2576** would also provide related conformity to federal law with respect to the allowance of rollovers from Archer Medical Savings Accounts, health flexible spending arrangements, or health reimbursement accounts to a health savings account. California is one of only three states that do not conform to federal tax law on HSA deductibility.

The Internal Revenue Code allows tax-free savings into an HSA for medical expenses. Up to 100% of the deductible amount of an accompanying high-deductible health insurance policy may be contributed to an HSA by either the employee account holder or the employer, or both. Funds are completely portable and may be carried over from year to year during a participant's lifetime.

HSAs have proven to be a great financial and medical benefit for employees and employers. California is one of five states that currently taxes contributions to HSAs. Employees throughout most of the nation enjoy both federal and state tax-free contributions to HSAs. It is very surprising that in such a high cost state as California, the same tax advantage has not been provided to California workers before now.
