**SUBJECT: AB 1751, AB 1752, AB 1753 (Low): CONTROLLED SUBSTANCES: CURES DATABASE – SUPPORT ASSEMBLY BUSINESS AND PROFESSIONS COMMITTEE SET FOR HEARING: APRIL 10, 2018**

Dear Assemblymember Low:

The California Association of Health Underwriters (CAHU) **SUPPORTS** your measures **AB 1751, AB 1752, and AB 1753**, as introduced January 3, 2018, which collectively work to reduced abuse, dependency and addiction to opioids, potentially saving health care costs and, more importantly, human lives.

CAHU is proud to **SUPPORT** AB 1751 which would enhance the state's prescription drug monitoring program, Controlled Substance Utilization Review and Evaluation System (CURES), to allow California's prescribers, dispensers, regulators, and law enforcement to share information across state lines to help curb the overprescribing of controlled substances and prevent unlawful "doctor shopping." CAHU is committed to seriously combating the urgent opioid crisis, and wholeheartedly supports this data-driven solution to prescription drug abuse.

CAHU **SUPPORTS** AB 1752 which would make much-needed improvements to current required data reporting to CURES by adding Schedule V controlled substances to ensure that all drugs containing opioids are appropriately tracked. The bill also helps prevent unlawful "doctor shopping" by providing prescribers with more real-time access to a patient's prescription history.

CAHU **SUPPORTS** AB 1753 which would significantly improve the state's ability to address fraudulent and stolen prescription pads, which contribute greatly to the growing opioid abuse crisis. Allowing the California Department of Justice to limit the number of Security Printers and requiring standard serialization across pad manufacturers will aid law enforcement in identifying criminal diversion of these pads, and ultimately prevent illegitimate and dangerous drug prescription.

Our members help millions of individual Californians and businesses evaluate, select, purchase and use their health care coverage plans, resulting in greater health and financial security--all at no cost to the consumer.
