Dear Dr. Wood:

The California Association of Health Underwriters (CAHU) is pleased to **SUPPORT** your measure **AB 2789**, as amended April 3, 2018, which would help reduce overprescribing or fraudulent prescriptions. This bill is one of several coordinated measures to curb opioid addiction and abuse, and decrease the associated high costs of prescription drugs on healthcare premiums, and human lives.

CAHU **SUPPORTS AB 2789** which would require health care practitioners authorized to issue prescriptions to have the capability to transmit electronic transmission prescriptions, and would require pharmacies to have the capability to receive those transmissions. CAHU believes the requirement that prescriptions be submitted electronically, with limited exceptions would help to reduce fraud, eliminate prescription errors and facilitate information in the state's CURES database to be available to prescribers in a more timely fashion.
