A Message From Bruce Benton, RHU, REBC, CAHU President

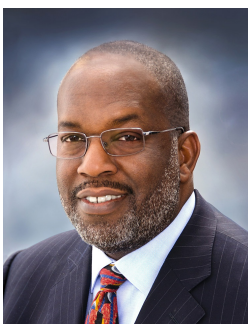
The purpose of an industry trade association is to represent the interests of its members. It provides the mechanism necessary to make the voice of the industry known in the law-making process.
